1. Do you have a Trust-wide obesity and weight management strategy	No
2. If so, how is this implemented (for example, through delivery of Tier 3 obesity services of the NHS Tiered Care Weight Management Pathway)?	Delivery of Tier 3 Services.
3. Details of staff training to deliver these strategies.	Consultant with specialist interest leads these services. Staff within these services undergo regular training to deliver these services as part of SCOPE obesity education.
4. Details of any current training for clinical staff in the area of weight discrimination, weight stigma, weight bias and/or obesity awareness,	We have undertaken one grand round on this – more work is in discussion and planned but not yet implemented.
5. The number of complaints made to the Trust where weight discrimination, bias or stigma was mentioned in the period	We are only able to search back as far as 01/02/2016 as that is how far back our data system covers.
